

The DAOR Bylaws establish affiliated membership for real estate owners and other individuals or firms engaged in activities related to the real estate profession who do not qualify for REALTOR® membership and have interests requiring information concerning real estate and sympathy with the objectives of DAOR. Affiliate members are not eligible to vote or hold elective office and have the right and privileges and are subject to the obligations prescribed by DAOR’s Board of Directors.

The DAOR policy manual provides that it is a violation of membership duty for an affiliate members to engage in conducts that is inconsistent with the objectives and purposes of DAOR, including using affiliate membership to compete with DAOR. Such conduct may subject affiliate member to discipline, probation, suspension, or termination of membership pursuant to the Bylaws.


