# **ADDENDUM No. 1**

## **PROCEDURE FOR ADDENDA**

This Addendum forms an integral part of the Tender Document and the subsequent Contract with the successful Tenderer. The Variations and amendments to the Tender Document as described hereafter shall take precedence. Notwithstanding anything said during the Tender Period or Site Inspection, only the additional information of variations and amendments contained in this Addendum, and subsequent Addenda, if any, will be legally binding.

Bidders are required to make any corrections of amendments instructed in Addenda by deleting and adding such text in the Tender Document and to sign to such amendment in black ink before making copies for submission of the Bid.

Addendum No.1 refers to the exclusion of **C 1.3** referred to in the document under **Item 7: “CONTRACT DATA – Special Conditions of Contract”**.

Furthermore, the Client omits the statements made under **C1.2: BID CONTRACT DATA**. The Client omits the following;

1. *“Each item of data given below is referenced to the clause in the Conditions of Contract to which it mainly applies”*.
2. *“The Contract Data shall have precedence in the interpretation of any ambiguity or inconsistency between it and Procsa”*.

The Client states under **C1.2 – BID CONTRACT DATA** to add the following:

1. *“The appointed Service Provider will be required to purchase a PROCSA which will be entered into as a Bid Contract between the Service Provider and Client”*.
